Bibliographic references in the text are made in square brackets [2, p. 67–68]. The use of automatic links is not allowed. The text uses only quotation marks « », replacement of dashes with hyphens is not allowed.

The list of used sources is made out according to DSTU 8302: 2015. The theses indicates no more than 5 sources.

The Organizing Committee reserves the right to reject materials that do not meet these requirements.
