Course Overview

The discipline "International Family and Inheritance Law" is devoted to the study of the problems of legal regulation of closely related family and inheritance relations of a cross-border nature in the context of globalization and European integration. The discipline covers the main institutions of international family and inheritance law, focusing on the most complex theoretical issues of conflict of laws regulation and prospects for unification of substantive and conflict of laws rules in this area.

The aim and tasks of academic discipline

The aim of the academic discipline is to acquire professional knowledge in the field of legal regulation of private law aspects of family and inheritance relations of an international nature, and to develop practical skills in their application in law-making, law enforcement, law enforcement, expert advisory and pedagogical activities.

Tasks:

- formation of a system of theoretical knowledge about the main institutions, concepts and categories of international family and inheritance law;

- mastering the main provisions of Ukrainian legislation in the field of conflict of laws and substantive law;
- understanding the current state of international family and inheritance law;
- mastering the skills of interpreting and applying conflict of laws and substantive rules of family and inheritance law;
- mastering the skills of legal analysis of factual circumstances in specific legal relations;
- mastering the skills of individual work with normative sources; use the achievements of the science of private international law.
- -mastering the skills of legal qualification of situations in family and inheritance cases with a foreign element and the ability to draw up legal opinions, statements, claims, and responses to claims, complaints, appeals, contracts and other legal acts in accordance with the rules of legal technique, using innovative technologies and information security standards.

The place of the discipline in the structure of the educational-professional programme.

Prerequisites: "Tax Law", "European Union Law and its System", "Actual Problems of Research Methodology".

Credentials: "European Private International Law", "International Contract Law", "WTO Law".

Postgraduate qualifications: "International Intellectual Property Law, EU Corporate Law and Governance, Notary and Notarial Actions of Consular Offices.

As a result of mastering the discipline, a higher education student must demonstrate the following learning outcomes:

the historical stages of its formation.

- LO 3. Demonstrate knowledge of the principles of international family law and their legislative consolidation.
- LO 4. Use knowledge of human rights in the field of family and marriage, and the practice of the ECHR on the protection of family and private life.
- LO 5. Analyze the current state of Ukrainian legislation in the field of international family relations and establish its compliance with international and European standards.
- LO 6. Resolve conflicts of laws regarding the form of marriage and the right to marriage.
- LO 7. Demonstrate knowledge of current issues of international regulation of intercountry adoption and its consequences.
- LO 8. Have the skills to resolve conflicts of laws governing legal relations between parents and children.
- LO 9. Demonstrate knowledge of doctrinal approaches to the definition of the concept of international inheritance law and its system.
- LO 10. Be able to apply the conflict of laws formulas lex personalis, lex nationalis, lex rei sitae and lex voluntatis to resolve conflicts of laws governing cross-border inheritance.
- LO 11. Analyze and resolve conflicts regarding cross-border fiduciary management of inheritance and recognition of inheritance trusts.
- LO 12. Analyze and resolve conflicts of interest regarding cross-border business inheritance, corporate rights and rights of heirs of beneficiaries of offshore companies.

Lecturer's requirements

Students *must*: regularly attend practical classes; systematically and actively work in lectures and practical classes; give full and thorough answers to questions; justify their point of view when discussing the report; fully and convincingly provide arguments when solving problems; analyze the rules of private international law, analyze judicial and law enforcement practice; perform written practical assignments, tests and independent work in a quality manner. Practical classes missed for valid reasons may be made up by prior agreement with the instructor.

Students are *encouraged to*: participate in scientific conferences, competitions of scientific papers, the work of the international law scientific circle, write scientific articles, take additional online courses on the recommended educational platforms. The teacher takes into *account* other educational and scientific achievements of the student that are documented (certificates, diplomas, certificates, etc.).

Students are required to comply with the Code of Academic Ethics of the Yaroslav Mudryi National Law University

The instructor pays special attention to compliance with the plagiarism policy. If signs of violation of the rules on the prevention of plagiarism or independence of writing the work are detected, a decision may be made to cancel the grade for the work.

Attendance at lectures and practical classes is mandatory. During both lectures and practical classes, students have the right to ask the instructor questions at any time on the relevant topic and are invited to actively participate in the discussion. During class, please use gadgets only for educational purposes (e.g., to view lecture presentations, take notes, and keep track of relevant information). In case of emergency, you may leave the classroom without disturbing the teacher and other students.

Control measures of learning outcomes

Evaluation of the results of mastering the discipline "International Family and Inheritance Law" involves ongoing monitoring and final control and is carried out on the basis of a cumulative point-rating system.

Types of ongoing monitoring:

- quality control of students' mastering the program material of the discipline in practical studies using the following means: oral, written or express survey, completion of test tasks, solving practical problems or tasks, defense of a portfolio of judicial practice in cases with a foreign element, defense of an essay at the initiative of the student, etc. The ongoing monitoring is aimed at checking the student's level of preparation in studying the material. During practical studies, a student can receive a grade on a five-point scale (0, 2, 3, 4, 6);

During the semester, students complete assignments for *independent work* (processing data from the Unified State Register of Court Decisions, generalizations of court practice in cases with a foreign element; preparation of abstracts for scientific and practical conferences and articles; completion of online courses on the recommended platforms of international organizations; conducting research

(project) on a narrow issue with its subsequent presentation, etc.) The work is individual and independent, and therefore co-authorship of students and other forms of assistance to each other are not allowed. When performing independent work, the student is obliged to comply with the rules of academic integrity and the prevention of plagiarism. The maximum number of points for independent work is 10.

The form of *final control of* knowledge of higher education students in the discipline is a credit test. The minimum number of points for receiving a credit test is 60.
