1. Goal and task educational disciplines.

Unauthorized sale or distribution of information from limited access, which stored in electronic computing machines (computers), automated systems, computer networks or on carriers such information: composition criminal offense, qualifying features. Unauthorized actions with information processed in electronic computing machines (computers), automated systems, computer networks or stored on such information media, committed person, which has right access to her: warehouses criminal offenses, qualifying signs. Violation rules operation electronic computers, automated systems, computer networks or networks telecommunications or order or rules protection information that is processed in them: the composition of a criminal offense. During the semester, students perform *independent work* in the form of preparing individual work (abstract, article, report abstract, essay, etc.). The

maximum number of points for individual work (abstract, article, report abstract, essay, etc.) is 8 points.

Form final control knowledge applicants higher education with academic discipline there are exam. Maximum number points, which student can get for the exam is 60 points. The minimum score of the results ongoing control and independent work, during which the student is allowed to exam, constitutes 25 points.
